ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION

Pursuant to the applicable provisions of the Utah Revised Nonprofit Corporation Act §16-6a-1002. Wyngate Town Homes Owners Association, Inc. (the "Corporation") adopts the following Articles of Amendment to Articles of Incorporation:

FIRST: The following amendment to the Articles of Incorporation was adopted by the Board of Directors in accordance with U.C.A. §16-6a-1002 and replaces the current Section 5.02 of Article V in its entirety:
