 - Repair costs for the three lights were \$272.15
 - The other street lights repairs will be determined at a later date.
- 4) The Board scheduled meeting items
 - The Board Discussed and approved the 2024 budget (The HOA dues remained at the same amount as 2023 {\$385.00})
 - The Board scheduled the annual homeowners meeting one day before the reserved conference room date (August 3rd, 2023 at 7:00pm, Layton City Library)
 - Discussed Board member voting and ballots process
 - The Board tasked Welch/Randall to send out the HOA homeowners notice of the annual meeting date, voting process documents and instructions
 - The Board approved the summer Newsletter and asked Welch/Randall to mail it out to all homeowners

 - Common area landscaping company costs for 2023: \$3,600
