Old Business

Financials

The Board reviewed the HOA financials prepared by Welch Randall (balance sheet, checking account balance, Reserve balance saving account and special assessment reserve were reviewed). Cathy made a motion to approve the financials, Natasha 2nd the motion and all voted in favor.

New business

- **4.** Landscaping Wasatch Lawn's bid for HOA landscaping came in at \$37,800 bid for the next year. The HOA Board postponed approval to see the HOA can negotiate more snow pushes.
 - a. Bid includes five snow removals. \$1,500 for each push after the five.
 - b. Randy to negotiate more pushes.
- 5. Insurance HOA master insurance switched to WCF. The deductible is \$10,000. Premium went from \$10,000 to \$13,000. The HOA Board approved WCF in September and the new policy is now in effect.
- **6.** Newsletter add a reminder to clean your dryer vent.
- 7. Property Review Randy created a property review form to help the board be consistent. It is recommended to send a photo for homeowner violations. Each Board Member will be assigned 12 units to review, to cover all the properties. Randy suggests that board members go in pairs, each person takes 12 forms (3 buildings each).

- **9.** Water Smart The HOA Doesn't qualify for the Water Smart Flip Your Strip rebate program. Ogden City's policy excludes HOA's that have multi-family buildings. Cathy mentioned that the Board can submit a request to City Council for revision to the policy.
