## WITNESSETH:

- On September 6, 2002, the HOA's CC&Rs were executed by the Declarant at the time (Aberdeen Moors, LLC) and recorded in the Salt Lake County Recorder's Office (BK8367174).
- On September 27, 2002, the HOA's By-Laws were executed by the Declarant at the time (Aberdeen Moors, LLC) and recorded in the Salt Lake County Recorder's Office (BK8655).
- 3. The Community Association Act, 57-8a-502(b), UCA, provides that the period of administrative control for the Declarant is terminated seven years after all Declarants have ceased to offer lots for sale in the ordinary course of business. Pursuant to this provision, the period of administrative control by the Declarant has terminated

4. The Community Association Act, 57-Sa-501, UCA, provides that a Board acts in all

instances on behalf of the Association.

5. II.9(b) of the CC&Rs provides that an amendment shall be effective when

executed by the HOA Board President and recorded in the Salt Lake County Recorder's Office.

6. The Board having determined that whenever HOA fees are increased, the

Board's HOA fees should be increased by the same percentage as the rest of the community.

NOW, THEREFORE, the HOA's Bylaws and CC&Rs are amended as follows:

1. <u>By-Laws:</u> Article 4, Section 4 "Compensation" shall read as follows: "Whenever

HOA fees are increased, the Board's fees shall be increased by the same percentage as the rest

of the community.

2. CC&Rs: Section 8.7(d) shall read as follows: "Whenever HOA fees are increased,

the Board's fees shall be increased by the same percentage as the rest of the community."
