**FIRST AMENDMENT TO THE BYLAWS
OF
HILL FARMS SUBDIVISION HOMEOWNERS ASSOCIATION, INC.**

This First Amendment to the Bylaws (hereinafter “First Amended Bylaws”) of Hill Farms Subdivision Homeowners Association, Inc. (“Association”), hereby amends those certain Bylaws of Hill Farms Subdivision Homeowners Association, Inc. (“Bylaws”) recorded on August 29, 2016, as Entry No. 2962280 in the office of the Davis County Recorder, Utah, and are hereby adopted by Legacy Neighborhoods, LLC, a Utah limited liability company (hereinafter “Declarant”), for and on behalf of the members, and made effective as of the date recorded in the Davis County Recorder’s Office.

RECITALS:

- (A) The First Amended Bylaws affect and concern the real property located in Davis County, Utah, and more particularly described in the attached **Exhibit “A”** (“Property”).
- (B) The Bylaws of Hill Farms Subdivision Homeowner Association, Inc. (“Bylaws”) were recorded on August 29, 2016, as Entry No. 2962280 in the office of the Davis County Recorder, Utah.
- (C) The Project remains within the Class B Member period, as set forth in Article 23.4 of the Enabling Declaration and Article 11.1 of the Bylaws.
- (D) Pursuant to Article 11.1 of the Bylaws, these First Amended Bylaws are hereby adopted by the Declarant.

NOW, THEREFORE, pursuant to the foregoing, the First Amended Bylaws shall be effective as of its recording date.

BYLAWS

- 1. Recitals. The above Recitals are incorporated herein by reference and made a part hereof.
- 2. No Other Changes. Except as otherwise expressly provided in this First Amended Bylaws, and any subsequent amendments, the Bylaws remain in full force and effect without modification.

3. Authorization. The individuals signing for the respective entities make the following representations: (i) he/she has read the First Amended Bylaws, (ii) he/she has authority to act for the entity designated below, and (iii) he/she shall execute the First Amended Bylaws acting in said capacity.

4. Conflicts. In the case of any conflict between the provisions of this First Amended Bylaws and the provisions of the Bylaws, the provisions of this First Amended Bylaws shall in all respects govern and control. In the case of any existing provision with the Bylaws that could be interpreted as prohibiting the modifications set forth in this First Amended Bylaws, such provision is hereby modified in order to accomplish the purpose and intent of the First Amended Bylaws.

AMENDMENTS

5. Article 3.4 of the Bylaws is hereby deleted in its entirety and replaced with the following:

Section 3.4 Quorum. Unless otherwise specifically set forth in the Declaration, at any meeting of Owners, a quorum shall be established by those Owners present, in person or by proxy, at a properly noticed meeting. Notwithstanding, the Board remains the only authorized body to act for and in behalf of the Association. Further, a majority of those Owners present in person or proxy at such meeting may vote to reschedule the meeting based upon low attendance. Otherwise, the meeting shall proceed as scheduled.

6. Articles 4.1 and 4.3 of the Bylaws are hereby deleted in their entirety and replaced with the following:

Section 4.1 Number, Tenure and Qualifications. The Initial Board shall be selected or appointed by Declarant, which may consist of three (3) or five (5) individuals and their successors that may hold office by the appointment of the Declarant, so long as Class B Control Period remains.

At the first meeting of the Members following the Class B Control Period at which the election of Directors will take place, a majority of Owners, a quorum being met, may determine whether to have a three (3) or (5) five member Board for the upcoming election. Members of the Board of Directors shall serve for a term of three years; provided, however, that at the first election following the adoption of these Bylaws, the Board shall identify one of the three member Board or two of a five member Board to serve for two-year terms. The other members shall serve for a three-year term. Thereafter, all members elected each year shall serve for a three-year term. The members of the Board of Directors shall serve until their respective successors are elected, or until their death, resignation or removal. Any change in the number of Directors may be made only by amendment of these Bylaws.

7. Article 10.1 of the Bylaws is hereby supplemented and modified to specifically provide for the appointment of multiple Architectural Review Boards in addition to other committees, which respective authority and responsibly may be governed by resolution of the Board.

8. Articles 14.1 and 14.2 of the Bylaws are hereby deleted in their entirety.

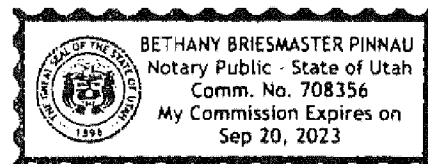
