ARTICLES OF ORGANIZATION

The undersigned hereby forms a limited liability company (the "Company") pursuant to the Utah Revised Limited Liability Company Act and adopts as the Articles of Organization of such limited liability company the following:

1. Name of the Company. The name of the Company shall be:

2. Period of Duration. The duration of the Company shall be ninety-nine (99) years from the date of filing of these Articles of Organization with the Division of Corporations & Commercial Code of the State of Utah; unless earlier terminated pursuant to the Operating Agreement of the Company.

3. Purposes of the Company. The purpose for which the Company is organized is to conduct any authorized business under Utah law. The Company shall have unlimited power to engage in and do any lawful act concerning any or all lawful businesses for which limited liability companies may be organized according to the laws of the State of Utah, including all powers and purposes now and hereafter permitted by law to a limited liability company.



10. Operations. The Company shall be governed by a written Operating Agreement, the terms of which shall supplement the provisions of Utah law.


