



Floor Insulation	Increments of R-19 or higher	Yes**	\$0.20 per sq. ft.
Attic Insulation - Tier 1*	A minimum of R-19 must be added with a post installation value of at least R-38 but not more than R-60	Yes**	\$0.25 per sq. ft.
Attic Insulation - Tier 2*	A minimum additional increment of at least R-11 must be added with a post installation value of at least R-38 but not more than R-60	Yes**	\$0.07 per sq. ft.
Duct Sealing and Insulation (Single-family)	Must meet <a href="#">Duct-Sealing and Insulation Specifications</a>	Yes	\$100 plus \$5.25 per linear foot (not to exceed \$450)
Duct Sealing and Insulation (Multi-family)	Must meet <a href="#">Duct-Sealing and Insulation Specifications</a>	Yes	\$100 plus \$5.25 per linear foot (not to exceed \$250)

Continuous Exterior Rigid Insulation	≥R-5 continuous insulation; gas space heating is required; must not be required by code; installation must not interfere with ventilation requirement outlined in applicable International Mechanical Code	No	Single-family \$0.40/sq.ft. (not to exceed \$800.00 per residence)  Multi-family \$0.40/sq.ft. (not to exceed \$400.00 per residence)

\* The final attic insulation R-value at a premise must be between R-38 and R-60.
