These pages are an addition to the Declaration of Condominium for FALCON RIDGE ESTATES a condominium, which was recorded on S Sep 97 under Davis County Recorder's number E1345280 B2172 P1056, and includes Amendment 1, record on Dec 3, 1997, under Davis County recording number E1 364808 B 2210 P 1067 and Amendment 2 recorded on Dec.6, 97, under Davis County Recording number E 1364808 B 2210 P 1067. This addition shall know as Amendment 3.

Amendment 3

This amendment is to clarify the percentage of ownership in the common areas after Buildings E and F were added to the condominium project.

Therefore, the First Amendment, pg. 3. "Interest in Common Areas" shall hereby be changed to read as follows:

II. Interest in Common Areas Pursuant to the provisions of Section 57-8-13.10 of the Utah Condominium Ownership Act, as amended, and subject to the provisions of ARTICLE VII, section 6 of the Declaration, the percentage of ownership in the common areas for all purposes attributable to each unit is 417% and shall be appurtenant to each unit and shall pass with the title top each unit. The percentage interest for each unit for voting purposes shall not be fractionalized.

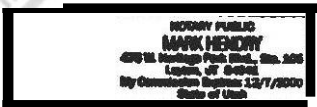
